If an Architectural improvement, the application must include an official copy of your plot plan, a full <u>written</u> <u>description</u> of the improvement, a detailed drawing showing <u>all</u> pertinent dimensions and \$250.00 deposit. Include pictures or literature of materials being used. **Check payable to Prairie Villas HOA.**

If a Landscape Improvement, provide all the information noted above, a **\$250.00** deposit plus a description of the stone, mulch and trees or shrubs you plan to install. Your drawing should include the location of all irrigation heads which is the home owners' responsibility to redirect or reroute the irrigation system as needed. Irrigation heads will not be allowed to remain in planting beds.

In submitting an application, the homeowner assumes full responsibility for the <u>maintenance</u>, <u>upkeep</u>, <u>replacement</u> or <u>removal</u> of the improvement!

Homeowner acknowledges and has read the Association Covenants, Conditions and Restrictions AND Association Guidelines prior to submitting their Application Form. Homeowner agrees to abide by the decision of the Board.

The applicant, <u>and any subsequent owner</u>, is wholly responsible for all initial and recurring costs and liability associated with the installation, maintenance and repair of the described alteration. The Homeowner further assumes all responsibility for any damage to any common elements and/or injury that may occur as a result of the alteration and shall minimize interference and inconvenience to others.

If the modification <u>is not</u> completed as approved, said approval can be revoked and the modification will be required to be removed by the Owner at Owners' expense, or modified to the acceptance of the Association. The Owner shall be responsible for reasonable costs and expenses to ensure compliance with Association standards, including attorney's fees. If an exterior change request is wholly or partially denied, the applicant may resubmit the request within thirty (30) day further detailing its merits. The Association shall re-review the request and render a final decision.
